# CRAFTER AGREEMENT

1. Booths must be open by 10:00 am and remain open until 5:00 pm
2. Booth set-up times: **Friday 3 – 6 pm; Saturday 8 – 10 am**
3. One table and two chairs will be furnished for a regular booth; two tables and two chairs will be furnished for a corner booth.
4. Crafters are responsible for bringing all supplies required for their display.
5. Sales tax is the responsibility of the crafter.
6. No concession-type items may be sold by crafters (ex: no coffee, sodas, sandwiches).  
Please Note: packaged homemade goods are not considered a concession item.
7. No garage sale type items may be sold.
8. The FS Chamber of Commerce has the right to have crafters remove unsuitable items.
9. Booths are assigned **on a paid, first come, first served basis.**
10. Spaces will be assigned by the FS Chamber of Commerce for the show convenience.
11. The FS Chamber of Commerce has the right to reject any application
12. The FS Chamber of Commerce and the Pecos County Civic Center disclaim any responsibility for loss or damage of any kind.
13. No smoking is allowed inside the Civic Center.
14. Crafters are responsible for keeping their area clear of litter before and during the show. **All litter must be removed from the crafters at the end of the show**
15. Crafters must have cleared their area and be out of the building **no later than 6:30 pm**
16. Vehicles are to be removed from the front of the building after unloading.
17. All crafters are requested to participate in the door prize giveaway for the show.
